

Contract for the arrangement of the Floorball Champions Cup

Between: International Floorball Federation,
Alakiventie 2, 00850 Helsinki, Finland (hereafter IFF) as first party,

and

the Czech Floorball Union (Ceska Florbalova Unie)

the Finnish Floorball Federation (Suomen Salibandyliitto ry)

the Swedish Floorball Federation (Svenska Innebandyförbundet)

the Swiss Floorball Association (Schweizerischer Unihockey Verband)
Ostermundigenstrasse 69, Postfach 621, CH-3000 Bern 22, SWITZERLAND
(hereafter the NA's)

The parties agree upon the need to arrange and organise an yearly European Top Club competition under the aegis of the IFF, in order to create a show case for International Floorball for the period of 2011 – 2014.

- § 1. The Champions Cup will be organised once a year during the period of 2011 – 2014 in October by the NA's. The order for organising, which has been agreed upon is 2011 the Czech Republic, 2012 Sweden, 2013 Finland and 2014 Switzerland.
- § 2. The Champions Cup will be organised in accordance with the IFF Regulation for the Champions Cup, approved by the IF CB.
- § 2.1. The cost allocation system as stated in the 'Regulations for Organisation of the Champions Cup' applies for all stakeholders with the exception of the Swiss association. The Swiss association will pay every year the maximum approved cap on costs as proposed by the organizer. Subsequently the Swiss association will therefore propose a maximum approved cap on costs for organizing the Champions Cup in Switzerland to all participating teams respectively to their appropriate National associations.
- § 3. The Champions Cup will initially be played as a six men's and women's team event, during five days, in accordance with the IFF regulation for the Champions Cup in a single venue. After the first edition the stakeholders will evaluate the competition system in November 2011, possibly additionally using an external company.
- § 4. A separate contract for organising the Champions Cup shall be made between the IFF and the NA in question.
- § 5. The parties concerned agreed to that changes to this contract can be made only in a joint meeting in November every year after the Champions Cup has been played.

- § 6. The parties concerned agree to keep the content of this agreement confidential with-in the Central Boards of their organisations.
- § 7. The Finnish and the Swedish associations committes to each pay a sum not exceeding EUR 25.000 to the Czech association, as compensation for a possible loss, if there for one or the other reason, after a decision November 2011, will not be organised a second edition of the Champions Cup in 2012.
- § 8. The Swiss association committes to compensate for 2011 a sum not exceeding EUR 25.000 in favour of the Czech Floorball Union, but they will internally agree with the clubs concerned, upon whom is to pay the possible sum for 2011. For the next consecutive years a maximum approved cap costs will be proposed by the National Association in charge to the Swiss association.
- § 9. The parties concerned agrees in good faith, to sign a new contract for the continuation of the Champions Cup for 2012 – 2014 after the evaluation process in November 2011.
- § 10. This contract may not be transferred by NA's to a third party,without the approval of the IFF. This contract has been signed in five originals, one for each party.
- § 11. Any modifications to this contract must be made in writing and has to be agreed upon separately between the two parties. In the event, that questions as to matters not mentioned in this agreement arise, they shall be negotiated in good faith between the parties concerned.
